It was nice to have such a large group of polys (15) in the show hall at the Cats & Tulips show. And of course as always we had lots of material to display, this time in 2 stands at different locations in the show hall. Ken out did himself by printing tons of newsletters, flyers and business cards and Deb had to carry it all the way to... Holland. 😊 And we had pictures of poly cats from Miriam, magnets, postcards and of course the digit definitions with this time some pictures to explain the pads and digits a little better. Every supporter got a great button with the new show supporter's logo on it, with thanks to Beryl, who set up the online shop for it and Cathy who brought it with her from the US.

We wore our button with pride. 😊 And of course we have to thank Hugo and Winnie for finishing this great log. 😊

So we were there to promote champion status for the MC poly, but we were also there to get some insight in what the MC breeders at the show thought about the Maine Coon poly as future competition in the Maine Coon classes of TICA. 😊

We already had the questionnaire that was used earlier this year at a show in the US (English version). So we re-used it and I made a special 'poly' box where people could put in their filled out questionnaire.



It was a bit hard to get the forms back since most exhibitors were in the ring busy with watching their cat, but during my 'hunt' for filled out questionnaires, I did manage to get some in the box and also had some interesting conversations with some MC breeders.

In total I received 21 forms. Some of the voting came from MC exhibitors that were there with a poly (although not all of them voted, they already expressed their voice by coming with their poly. 😊) But we of course also received votes from other MC breeders in the show hall. This was the questionnaire form:

We would like your answer and opinion on a couple of questions. You do not need to sign your name, but we would like your honest thoughts. A proposal will be made in 2008 to TICA for acceptance of Championship Status for Maine Coon polydactyls. We would like your feelings on:

Of the 21 votes, 13 voters agreed with them being accepted for show status and didn't object to them being shown in the same class as the other Maine Coons. Then I got 3 votes of people who basically voted the same, but didn't understand the question well. On the first question they agreed and on the 2nd question they voted "yes" (which means object to showing them in the same classes as other Maine Coons) and explained this with answers like:

- *"It's a Maine Coon"*
- *"It's a MC so an extra toe should not matter"*
- *"Same breed"*

So I will add these 3 votes to the 13 that voted for show status and showing them in the MC classes too;-). So that makes 16 votes for the polys.

Then the 5 votes we, IMO, can learn the most from: 3 votes agreed on accepting the Maine Coon poly for show status, but objected to them being shown in the same classes as the other Maine Coons. Their reasoning was as follows:

- *"They're Maine Coons with something extra"*
- *"Because it's still a different type of cat"*
- *"Because they're still different in my eyes"*

Then there were 2 voters left:

One opposed to the Maine Coon polys being accepted for show status and objected to them being shown in the class of the standard footed Maine Coons.

Reason:

- *"Because I find it a deformity"*

The last voter opposed to them being accepted for show status too.

Reason:

- *"My opinion is that a cat should have the natural normal numbers of toes. I'm afraid, that there may be a contest between the Poly-breeders who would have the cat with the most toes. And perhaps will produce cats with less quality"*.

On the question if the voter would object to them being shown in the same class, the voter said no, BUT wrote: "they shouldn't be shown at all".

These aren't things we haven't heard before. What did surprise me, was that some breeders wanted a separate class for the polys. I hadn't expected to hear that from Dutch MC breeders. 😊 One breeder commented on the lack of type in a lot of polys. When I told them polys prior haven't had the chance to be shown like the standard footed MC's have over many years, I was told that was not a good enough reason. Then I said don't you bring your cats/kittens to a show to hear what the judge has to say? The breeder said no, I only show what I like myself. But admitted that the extremer, more slim type ruled the show and that's why there were more sturdy build, old typed females in this breeder's house---so to compensate the boning. When I asked if these females were shown too, the answer was no. This breeder didn't think much of the polys but wouldn't hesitate to buy a poly when the cat had the type. But still would like to see it in a separate class. So I said then it can't compete with the standard footed MC's? But it was pointed out that it could do so in the finals. When I asked why this breeder wanted to see them in a separate class so badly when the toes are only worth 3 points in the standard? The answer was the people with polys made a big deal about the toes themselves, wasn't that what it was all about? Sigh... 😊

Another conversation I had was with a nice breeder who doesn't agree with them being shown or bred, but isn't that fanatic about it: She has no problem with dealing with breeders who do breed with them either. So a different opinion should not be a problem at all. 😊

If we look at the votes again, 16 (76%) of the 21 voters want the polys to get show standard and being shown in the same class as their standard footed brothers and sisters. 19

voters were ok with the Maine Coon poly being accepted for show status (90%). 2 voters (9,5%) were against them being shown at all. 3 voters (14%) wanted to see them being shown in a separate class. So not bad results at all☺.

Overall, I think its good there're more and more MC polys seen in the show hall and that the NT class has bigger numbers of polys too. They will see we're serious and the polys are shown with proud. They're noticed and judges and breeders are getting used to them. And the visitors as always...love them, no matter the type. 😊 The MC polys are here to stay and they know it☺.

HELP US HELP YOU AND THE POLY

As you read through this newsletter, as well as previous issues, you can see a glaring point. The "Poly" is making a resurgence and is here to stay, this time! 40% seems to be the most quoted number, although no one really knows for sure. The 40% refers to the number of polydactyls occurring naturally in original feral stock from which the foundations were selected when the Maine Coon Breed was established some 40 plus years ago. You can argue those numbers and we would be unable to prove differently, but there is one thing we can all pretty much accept: The original cats roaming the eastern seaboard of the United States and Canada contained a significant amount of polydactyls that occurred naturally. When a trait occurs in a natural breed to the depth that polydactylism occurs in the Maine Coon then it is part of the Breed. You can like or dislike this feature, but you can't argue the fact that polydactylism is, has, and always will be part of the Maine Coon.

It was only through man-made decisions to cull this trait from the Maine Coon...not natural selection that the poly Maine Coon nearly disappeared. Again you can argue the reasons. The decision to not include the poly in the Championship ring was purely political and based on solely on choice. Even in the 60's, when the breed and show standards were being considered, there was ample evidence that polydactylism caused no quality of life issues and was a benign trait from a breeding standpoint. Since that time much noise and unsubstantiated claims have been made about all the bad things that will happen if you breed polys. But these same nay Sayers, when put to the test, cannot come up with a single scientific reason or documented study that shows any harmful effect.

So if we started with an estimated 40% polys in the beginning and the "cullers" were

able to get the population down to an estimated 1 to 2% by 2005, where are we today? I can't give you figure on that...but it is definitely on the rise. The Polys are coming back!

The question of the day: Why? The answer is because of breeders, fanciers, pedigree pet owners and poly show-ers in the rings today! It is because of you!!! In fact I have a couple of polys sitting not too far from my desk right now, who say thanks to all of you that are working hard to reintroduce the MC poly to the show world. They know they are special...we know they are special...and given the chance in the show ring they can prove to the world that they are not something to eliminate from the breed or the show hall for that matter.

Little has been studied of the origins and genetics of these lines. We at PolyTrak want to help you in your mission to publicize, study and document all poly MC's. But we can't do it without your help. So PLEASE stay in touch with us, send us your info and allow us to help you and the poly in the publicizing of facts and details of these cats. Submit today, the more than 100 polys that are not listed that we know about and probably many more that we are not aware of. You and the cats will benefit!
